

**JOINT ORDER OF THE DISTRICT COURTS AND COUNTY COURTS AT LAW OF MONTGOMERY COUNTY,  
TEXAS GOVERNING THE SERVICE OF PROCESS BY PRIVATE PROCESS SERVERS UNDER Tex.R.Civ.P. 103**

On the 1st of October, 1998, the judges of the District and County Courts at Law of Montgomery County, Texas signed an Administrative Order under No. 1998-24 creating a process for the approval of private process servers to serve civil process and criminal subpoenas in cases filed in those said courts. In Misc. Docket No. 04-9225, the Supreme Court of Texas ordered that certification of persons to serve process under Rules 103 and 536(a), Tex. R. Civ. P., would thereafter occur through the appointed Process Service Review Board, which has since become a body within the Judicial Branch Certification Commission. It is, therefore,
